



2-TONE REFLECTIVE SLEEVELESS JACKET

Description

Dromex® SA13-SL Class 2 high visibility ventilated two tone torso reflective safety wear is intended to provide conspicuity of the wearer in any light condition when viewed by operators of vehicles or other mechanized equipment during daylight conditions and under illumination of head-lights in the dark.

Part number SA13-SL reflective jacket features:

- A full zip closure system and elasticated waist with press stud fasteners.
- Detachable zip sleeves.
- Identity card holder on the left breast.
- Reflective tape on the waist, front, sleeves and back of the jacket for enhanced visibility from all sides.
- Passant (shoulder strap) on shoulder with snap closing for use with epaulets.

Class 2 safety jackets are required by law for anyone working near or exposed to vehicle traffic, road construction crews, utility workers, survey crews, airport ground crews, law enforcement, railway workers, school crossing guards and toll gate personnel amongst others and in dark areas.

Reflective safety wear is not intended as a workwear garment.

Compliance & Conformity

Complies to EN ISO 20471:2013 specifying the requirements for high visibility clothing which is capable of visually signalling the user's presence.

Specifications

Style Part number SA13-SL: Class 2, ventilated high visibility long-sleeve reflective jacket with zip closure, detachable sleeves, id card holder and allowance for branding on rear and front of jacket.

Materials: 100% Polyester Tricot mesh fabric.

Fasteners: Nylon zip fastener with metal zipper and buttons.

Reflective tape: 50mm and 15mm Silver micro glass bead.

Additional: Also available in sleeveless, Dromex® part number SA14-NS, without id card holder.



Packaging, Storage & Obsolescence

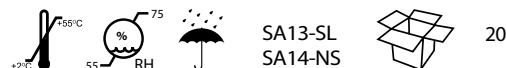
Dromex® SA13-SL and SA14-NS reflective wear is packed in individual polybags and sold as 20 units in a box.

When not in use or during transportation, the reflective wear should be stored in a container such that it is out of direct sunlight and not in contact with any chemicals, liquids or sharp objects.

Store in a cool dry place.

The reflective wear useful life is affected by many factors including the cold, heat, chemicals, sunlight and misuse.

Stored correctly, should have a shelf life of 3 years.

Small to 3XL.
